**Notice Concerning Change in Trade Names for Consolidated Subsidiaries**

**Tokyo, May 28, 2021** --- Mitsubishi HC Capital Inc. (TSE: 8593, Representative Director, President & CEO: Takahiro Yanai, “the Company”) hereby announces its decision to change trade names of its consolidated subsidiaries: MUL Property Co., Ltd., MUL Asset Finance Corporation, Hitachi Capital NBL Corporation, Hitachi Capital America Corp. and Hitachi Capital (UK) PLC.

**1. Reason for Change**

The Company implemented the Business Integration through an absorption-type merger (“the Merger”) on April 1, 2021, in which Mitsubishi UFJ Lease & Finance Company Limited was the surviving company and Hitachi Capital Corporation was the merged company. Together with the Merger, the Company’s consolidated subsidiaries decided to change their trade names as noted below. Please note, the new trade names and scheduled dates of change are premised on approvals by related authorities.
