## Mitsubishi UFJ Lease & Finance to Step up Automobile Lease Business in Indonesia

Mitsubishi UFJ Lease & Finance (the "Company") hereby announces that it will jointly commence an automobile lease business with PT. Takari Sumber Mulia ("TSM"), a major Indonesian automobile rental company, and to enlarge its automobile lease business in Indonesia and further improve the services.

In addition to the fact that Indonesia's population is more than 240 million, which is the 4th largest in the world, young people account for a large percentage of its composition. Accordingly, the country is deemed as one of the key ASEAN countries, and high economic growth is expected in the future. The country has a close relationship with Japan, and many Japanese companies, mainly manufacturers, have developed businesses in the country. Since the establishment of the Company's local subsidiary in the country in 1995, it has consistently provided various services to Japanese companies developing businesses in the country, and has also provided a wide range of product services to local companies that invest in machine tools, construction machineries, and other valuable properties for nearly two decades.

The Company decided to strengthen and promote its automobile lease business in Indonesia (a promising market, since automobile penetration is growing due to economic progress) by establishing a joint venture with TSM, a major automobile rental company with experience of more than 30 years in the business. The Company plans to hold 75% of the interests in the new company. It will manage the new company, which will be its consolidated subsidiary, as a member of the group. The Company will utilize the service facilities and local networks of the partner company, TSM, and provide high-quality automobile lease services that offer one of the best fleet line-up among Japanese automobile lease service providers in Indonesia.
