Acquisition of Auto Lease Company in the Netherlands to Provide Auto Leasing and Related Comprehensive Services across the Country

Tokyo, December 1, 2017 - Hitachi Capital Corporation (TSE: 8586) (President & CEO: Seiji Kawabe, "Hitachi Capital") today announced that its subsidiary, Noordlease Holding B.V. ("Noordlease"), engaging in auto leasing business in the Kingdom of the Netherlands ("the Netherlands") entered into an agreement with shareholders of Lease Visie B.V. ("Visie"), to acquire all outstanding shares of Visie as part of measures to strengthen Vehicle Solution*1 in continental Europe, and completed all procedures to make Visie its subsidiary on November 30, 2017 (local time in the Netherlands).

Hitachi Capital has focused on Vehicle Solution in Europe, which has high competitiveness in the U.K. Hitachi Capital started business in April 2014 in Poland and in January 2017 in the Netherlands.*2

Under such situation, Hitachi Capital Group newly acquired Visie which operates auto leasing business in Heerhugowaard, the Netherlands. In the Netherlands, the auto lease market has been expanding, and the related vehicle management services are also on an upward trend. With the acquisition of Visie providing leasing services of passenger vehicles and light commercial vehicles mainly to small and medium-sized enterprises in the western Netherlands including Amsterdam, we will provide Vehicle Solution across the Netherlands.

Hitachi Capital will aim at systematic growth on a global basis and continue to accelerate market development in continental Europe.
